



New opportunity in NH to localize control over energy supply, increase energy choices, and extend benefits of competitive market to residents and small businesses, including lower costs and consumer protections



#### **Customer Choices**

- Adds supply choices for lower cost and/or extra renewables
- All electricity customers can participate
- Automatic enrollment for customers not already on competitive supply
  - Default option; or
  - Select another program option; or
  - Opt-out, to stay with utility energy supply
- Comprehensive education and outreach
- No penalties or cancellation fees

#### Standard Power

- NH electricity broker serving over 65 municipalities and school districts including municipal buying groups
- Administrator of largest group net metering program in NH
- Solar/Hydro/REC integration for multiple communities

### **Getting Started**

Plan & Manage + Regulatory Form Your Team Outreach + launch Approve Monitor

- 1. Appoint a Community **Power** Committee
- 2. Sign MOU to receive draft materials and full assistance

- 3. Customize draft Community Power Plan with public input
- 4 Secure local approval of plan (Town Meeting or City Council)
- 5. Notify Public Utilities Commission and utility

- 7.Implement public education and optout campaign

6. Procure electricity

supply

- 8.Launch! Eligible accounts that have not opted out are automatically enrolled
- 9. Provide ongoing customer support, outreach, opt up campaigns, data management and analysis, planning, and more

### August 2021 Legislative update

#### **SB 91**

Renewable energy omnibus bill

#### **HB 315**

- Community Power bill "Relative to the aggregation of electric customers"
- Strong bipartisan support for bill as amended by working group consensus
- Support of the Governor's office
- SB 109 Municipal net metering rolled into HB 315
