Documents: When you visit the site, you should bring:

If married, both spouses MUST be present

Original (no photocopies) social security cards for taxpayer, spouse, if married, & any dependents being claimed

Picture ID for taxpayer & spouse (must be a Driver's License, or state issued ID Card, or other official document)

All W-2's for all places worked in previous year

Proof of real estate taxes paid in previous year-even if you are not itemizing your deductions

Routing number and bank account number for direct deposit

If applicable, bring:

Copies of any 1099s issued to you or you spouse

Bank account interest year-end statement

Student loan interest statement

Proof of child care expenses paid (statement from provider with EIN # or Social Security #)

Statement of post-secondary education tuition expenses paid

Social Security year-end statements

Any other documents related to your previous year taxes.

If itemizing your deductions, bring:

Copies of last year's mortgage interest statements (including any points paid)

Real estate taxes paid statement

Proof of charitable donations

Statement of work-related expenses

Auto registration

Receipt of tax preparation fees paid last year

Statement of safe deposit box fees

Statement of union dues paid

Any other statements of allowable itemized deductions

If business owner:

Proof of income and expenses (in writing).

Returns cannot be filed with rental income.
