# Town of Deerfield BOARD OF SELECTMEN January 9, 2017 MINUTES

#### **Call to Order**

5:30p - Chairman Barry called the meeting to order.

## Pledge of Allegiance to the Flag

Chairman Barry asks all to rise and pledge allegiance to the Flag.

#### **Scheduled Appointments**

Longevity Awards - 15 Years - Lieutenant Daniel Deyermond and Sergeant Michael Lavoie Chairman Barry announced Longevity awards for Police Lieutenant Dan Deyermond and Sergeant Michael Lavoie, both have served 15 years with the Department, neither was able to be in attendance.

#### **Safety Services Steering Committee**

Rebecca Hutchinson, Chair of the Committee, presented a recap of the group's formation, mission and activities associated with the NH Listens group. She reported that 40 residents attended the Open House at the Police Department and 20 at the Fire Department. The group also facilitated a town wide mailing explaining the Primex report. All who attended the November 12th meeting will receive a copy of the Committee's report by email next week.

Ms. Hutchinson cited three major findings of the year's work, 1) Status quo is not an option; 2) People are looking for a "Yankee Solution"; and 3) There is a need for ongoing community engagement and information sharing efforts. The Committee recommends that the Town form a Citizen's Planning Committee to begin phase two of the process. The new Committee should be comprised of smaller subcommittees charged with digging deeper into specific areas, for example visiting of neighboring facilities to learn from other Town's experiences. The Safety Services Committee also recommends that the Fire and Police Departments hold annual open houses. With the conclusion of the Steering Committee several members will be willing to stay on and serve during the next phase. Member Erin DiBacco has volunteered to visit with local organizations directly to provide the report of findings and continue the dialog.

The Select Board thanked the Committee for its work and expressed great appreciation. The report, along with the Committee's recommendations will be placed on the Town's website and Ms. Hutchinson plans to put an article in the Forum. Selectman McGarry asked which members would be willing to continue with a Citizen's Planning Committee? Ms. Hutchinson responded that Dwight Barnes and Matt Fisher have agreed to continue, Kevin Verville is unable to, and she and Erin DiBacco are undecided at the moment.
