## TOWN OF DEERFIELD BOARD OF SELECTMEN October 10, 2023 MINUTES

## Call to Order

5:30 - Chairman Pitman called the meeting to order

**Present:** Chairman Richard Pitman, Vice Chairman Fred McGarry, Selectwoman Cynthia McHugh, Selectman Will Huebner, and Selectman Steve Barry.

## Pete Schibbelhute – Planning Board Archives:

Mr. Schibbelhute explains that Erroll Rhodes has received 4 quotes for the organization of the archives room. Mr. Rhodes explains the 4 quotes for the planning board portion only:

- 1. Inception Technologies \$17,350.00
- 2. Morgan Records \$13,557.00
- 3. ARC Document Solutions \$23,268.00
- 4. ScanSmart \$38,790.00

The Board, Mr. Schibbelhute and Mr. Rhodes go to discuss all the ins and outs of this project and any extra costs.
