Signature – Letter from the BOS to Daniel Tripp with the Historical Society about the Town Hall Usage. Read into the minutes by Vice Chairman McGarry.

"Dear Dan, On Thursday, October 26, members of the Historical Society entered the Town Hall to use the kitchen to prepare lunch for people working on the new Historical Society Museum building. The day they arrived to use the kitchen facilities Ray Ellis, the Facility Supervisor, was there doing a final walkthrough to check that the building was clean and ready for an event to occur the next day by someone who had paid to use the Town Hall. When Ray explained that the members could not use the kitchen as it was clean and ready for the event, they proceeded to use the kitchen anyway to prepare the lunch.

The Board would like to remind the Historical Society that the Society has approved use of only the two rooms on the second floor for the museum, not the rest of the building, including the kitchen. If the Society would like to use other areas of the building outside of the two museum rooms, they must first check with Ray Ellis to determine if the Town Hall is available to use and then schedule the use with Ray. Although the Historical Society is waived from the non-profit rental fee of \$75.00, you are still required as a renter of the other areas of the building, to fill out and sign a rental agreement and provide a \$50.00 deposit payment to be held for cleaning services should the Town Hall not be returned in the condition it was found in and requires additional cleaning. The fee will be returned if the building is found in good order after you use it.

As you continue to remodel the new home of the Historical Society Museum, do you have an anticipated day you intend to occupy the building and move the items out from the Town Hall into the new building. This is the process followed by all other users of the Town Hall and it helps to ensure that everyone understands the use and limitations associated with events held in the building. The Board wants to

preserve the building for residents to use and enjoy for many years to come. We anticipate your cooperation as we work to maintain this historic landmark in Town. Signed, The Board of Selectmen"

Community Power Plan:

A letter from Kevin Verville is read into the minutes by Vice Chairman McGarry.

"Mr. Chair, and members of the board:

It has been brought to my attention that there are multiple vendors both willing and capable to work with the town of Deerfield relative to electric energy programs. Despite this fact, only one vendor has been considered by the select board, and invited to participate in a public hearing. How are we to know the preferred vendor if we are only presented one option?!

I am writing to you today to urge you to NOT take action on this matter until at least three vendors are allowed to publicly present their products and services to the citizens of Deerfield. This is standard operating procedure for any other decision of the is magnitude that we would take as a community.

Otherwise, it appears that a select few in town are picking the winners and losers, for reasons that are not clear to the general public.

There is no rush in moving such a proposal forward. The Deerfield select board should take all the time required to conduct a thorough evaluation of opportunities, and to conduct the fiduciary due diligence that is the responsibility of the select board.

Further, I respectfully request that this letter be read into the record during your meeting tonight. Respectfully submitted, Kevin Verville"

Chairman Pitman reads a portion of a letter from Freedom Energy Logistic.

"I wanted to let you know that my firm, Freedom Energy Logistic, offers Community Power (aka Community Choice Aggregation) in the state of New Hampshire. I understand the Board is currently reviewing options for this program and we would be grateful for an opportunity to come

and present to you before a final decision is made. Our New Hampshire clients include Londonderry, North Hampton, Hampton, Ossipee, Lincoln and Hancock in addition to the 90 communities our group manages in Massachusetts."

The Board agrees they should hear about other options.

Town Administrator's Report

John Harrington lets the Board know that the warrant articles in their folders are form last year and explains why they are there. He also provided a copy of the default budget for their review. Mr. Harrington then explains there is a request being made to rent the Town Hall once a month throughout the winter and the Board agrees not to move forward with this and keep it closed for the winter.

<u>Unfinished Business New Business/Other Business</u>

Vice Chairman McGarry would like to check in on how the research for the salary survey and salary schedule for the 21 employees of the town is going. Selectwoman McHugh states that she has all the information and she just needs to put it all together and Selectman Huebner would a like a special meeting to review the information. The Board agrees it should be public and added to the agenda of the next scheduled meeting.

Selectman Huebner brings up the higher tax rate and if there is a possibility to extend the dead line. Kelly Robert, TC/TX, believes it cannot be extended but agrees to check on it with the Town Council. Selectman Barry reads am explanation of the tax bill into the minutes.

Selectman Huebner comments on the calculated average over 49 years.

Chairman Pitman asks if they would like to go the warrant article tonight or wait until the next meeting. Selectman Huebner provides his reasons why he feels they should wait until the next meeting. Vice Chairman McGarry asks about looking doing the Police Station Warrant article again and the Board agrees, not this year.

The Board agrees to go over the warrant article at the next meeting.
