Call to Order

5:30 - Chairman Pitman called the meeting to order

Present: Chairman Richard Pitman, Vice Chairman Fred McGarry, Selectwoman Cynthia McHugh, Selectman Will Huebner (remotely), and Selectman Steve Barry.

Pledge of Allegiance to the Flag.

Vote to Allow Selectman Huebner to join the meeting remotely.

Ray Ellis – Town Hall Generator/Emergency Power

Mr. Ellis explains he reached out to 4 different contractors and only received 3 quotes. He has Chris Porter from Porter Electric with him at the meeting tonight. He submitted a quote for a stand-up generator and a battery pack that would replace the use of a generator. Mr. Ellis then explains the battery pack and how long it would last with a power outage and that he feels, in the long run, this is the cheaper route. He then lists the pros and cons of a battery pack verses a battery pack.

Mr. Porter piggy backs off Mr. Ellis' explanation and then fields questions form the Board.

Selectman Barry feels that the battery pack is the way to go and explains why he feels this way.

Vice Chairman McGarry goes over a few questions with Mr. Porter and then Mr. Porter explains more about the batteries and answers questions from Selectwoman McHugh.

Selectwoman McHugh feels they should get more estimates on the battery pack idea.

Selectman Huebner provides his opinion which idea is better, generator or battery, and agrees with Selectwoman McHugh that more quotes are needed.

Selectman Barry would like to see this installed before the election.

Motion: Selectman Barry makes a motion to with the battery pack from Porter Electric

Contracting for \$8,205.00. **Second:** Selectman Huebner

Discussion:

The batteries would be set up in the heated bathroom downstairs as they would fit perfectly in there with extra space and since there is electric heat in that bathroom it can be heated alone and they only have to heat that bathroom for the batteries, not the whole building.

They discuss further how the batteries work and the benefits of it.

Selectman Barry states he would like to add to his motion that the funds come from ARPA money.

Selectman Huebner questions why ARPA instead of the Building Maintenance fund for the Town Hall and Selectman Barry states that since the budget is still up in the air and ARPA needs to be used up by the end of the year they should go ahead and use it. Selectman Huebner would like to use town budget funds and not ARPA and would like to stay with the original motion.

- Letter from Standard Power dated 1/5/2024. Read by Vice Chairman McGarry.

"Representing Standard Power, we stand in support of the Deerfield Energy Committee, whose efforts have shaped an innovative Community Power plan (the "Plan").

The Deerfield Energy Committee has done their homework, hosted public hearings, conducted community surveys, and provided public education on energy matters. Their work has been effective in ensuring that Deerfield's Plan is compliant with New Hampshire's Public Utility Commission (PUC) requirements while reflecting the community's interests.

The next two steps in this process run in parallel with one another. The first step, which you took on December 4th, is to place the Plan before the voters on the March 12th ballot.

The second step, which we are asking you to take this evening, is to send the Plan to the PUC for approval, which should be given within sixty days. Should the voters approve the Plan at the ballot, having a PUC-approved Plan puts Deerfield's citizens in a position to start benefiting from lower rates sooner.

By way of comparison, similar initiatives to the Deerfield Plan have received approval from dozens of other town Select Boards and towns in Massachusetts and New Hampshire, highlighting the success and viability of such endeavors.

Deerfield's Community Power plan provides a tremendous opportunity to the town, offering a diverse range of electric rate choices that cater to various needs, preferences, and environmental aspirations as expressed by community members.
