Chair Serita Frey convened the meeting at 7:15 pm

Great Brook Trail – Tim Gross Eagle Scout Project:

Tim Gross presented suggestions for his Eagle Scout project to the members. Tim has selected the Great Brook Corridor for his project, based on research of the 2011 Trail Inventory. The plan is to preliminarily inspect the trail to take inventory of work that is needed, which could include clearing of brush and blowdown, re-blazing of trails, possible bridge renovation, and sign replacement.

It was suggested that Tim reach out to Al Jaeger, whose land is one of the several privately-owned parcels that comprise the Great Brook Corridor. Al's efforts to encourage his neighbors to permanently conserve their land, ultimately resulted in *connecting* the abutting parcels which now form the corridor. DCC members are welcome to participate in the evaluation. Other Town Forests previously targeted in 2021 for improvement projects are Lindsay-Flanders (trail maintenance, blazing and bridge construction over Nichols Brook), and Dowst-Cate (sign replacement, which may have been completed, and trail re-blazing). A trail extension from Peg King Park to the Gazebo was suggested in the past as well.

Andrew Ackerman, GZA - CUP Application G146 Transmission Line Structure Replacement Project

DCC provided a letter to the Planning Board outlining its baseline comments and recommendations based on the application and information obtained from Andrew Ackerman of GZA, during DCC's April meeting. It was reported that the Planning Board responded favorably to DCC's comments. The clerk reached out to Mr. Ackerman on May 2nd to **obtain a copy of the 4/19 Fish and Game recommendations**; however, there has been no response to date.

DCS Paving Project

DCC received copies of the plans for the proposed Deerfield Community School Parking Improvement Plan for review (DCC and Planning Board consultation were a condition of warrant article approval for the funding). It was noted that the site needs drainage and silt control, and catch basins that can be pumped out. The School Board has requested representation from the Planning Board and DCC at its May 17th meeting at 6 pm at DCS. Member Haley Andreozzi will be asked to represent DCC at the meeting, if she is available. Another suggestion was for DCC to reach out to Spencer Tate to attend on DCC's behalf on a volunteer basis.
