- 1. Initial informational meeting with the partners to discuss the proposed project late August 2016.
- 2. Conduct field work and prepare a suggested road design for Church Street in Deerfield Center September 2016.
- 3. Review findings with the project partners and Planning Board; revise the proposed design as appropriate October 2016.
- 4. Present the final recommendations to the Board of Selectmen November 2016

Please let us know how complete streets could help your community by describing the following:

1. What are the existing impediments (physical or otherwise) to full access for all users?

At present, the Church Street alignment is not defined. This design effort would narrow the traffic way and provide space for bicycling and walking on the road in Deerfield Center.

2. How could improving access to streets in your community improve safety, expand opportunities for use of the public way, encourage economic development, and/or increase tourism opportunities?

This project both encourages and promotes Deerfield Center as a safe bicycling and waking opportunity for its residents and visitors. Deerfield has a walking trail system to which this project can connect. This effort would enhance the safety and promote the use of the public way for uses other than the automobile. Town boards and interested citizens have long discussed this project and this initiative would provide an opportunity to prepare a "trail run" to test its feasibility.

Complete Streets component – Deerfield Center

This would be a design standard planning initiative. The Town and Planning Board have engaged in three major efforts regarding Deerfield Center: the PlanNH Design Charrette in 2000, the CLD Traffic Calming Study in 2003 and the Deerfield Village Design Charrette in 2013. In addition, Town officials met with Mr. James Marshall of the NH DOT and other DOT staff to discuss ways to improve the design of Church Street and the North Road / Church Street intersection. KNA has also provided guidance on this matter. As a result, there is a knowledge and information base from which to proceed.

In cooperation with its project partners, the Planning Board desires to apply a modified complete streets approach to Church Street and Deerfield Center by defining the width of the travelled way of Church Street and by providing a lane for bicycling and walking lane. The project will involve the close cooperation of the Deerfield Fire Department as they are located in the Center. It is to be determined if this project effort will include a new configuration for the intersection of North Road (aka NH Route 107) and Church Street. As noted, this initiative provides the opportunity to prepare a "trail run" to test its feasibility.

Work Tasks:

- 1. Meet and organize the planning initiative and discuss how to proceed with the project; agree on the most practical approach to design the "trial run."
- 2. Meet with the Fire Department, Library, Road Agent, property owners and interested persons to discuss the proposal and seek their input.
- 3. Prepare a design concept for the complete street / traffic calming project.
- 4. Review the design concept with the Planning Board, Board of Selectmen, Road Agent, Fire Department, property owners and interested person to receive their comments on the concept.
- 5. Modify the design concept based on local input.
- 6. Present the final design concept to the Planning Board, Board of Selectmen and Road Agent for approval.
- 7. Promote and publicize this effort through The Forum (local e newsletter), the Town's website and written information.
- 8. Apply the design concept to Church Street.
- 9. Monitor the results of the "trail run."

Complete Streets Pilot Program: Project Menu Items for Communities

• Pop-up planning initiative

o This will involve the planning of a temporary demonstration street segment, using materials such as tape and bollards to delineate bike lanes, wider sidewalks, or other Complete Street-recommended elements. Maximum length of street should not exceed 1,000 feet or two blocks, whichever is more applicable.

• Policy/resolution development

o This will assist your municipality toward developing a CS policy, using nationwide best practices and New Hampshire examples as guidelines.

• Design standards

 This will assist your municipality in developing design standards. A review and commentary on the appropriateness of existing planning documents could also be included if desired.

• Education/outreach

o This will involve educational assistance within a town. Planning commission staff will recruit individuals in whose communities Complete Streets have been explored in an effort to share experiences, successes, and challenges.
